## **INSTRUCTIONS**

- 1. Keep a separate record-sheet on each stallion used for breeding purposes.
- 2. Report must be filed in the office of the Percheron Horse Association of America not later than January 31st of each calendar year, for the preceding year. Mail to Percheron Horse Association of America, P.O. Box 141, Fredericktown, OH 43019 or email to percheron@percheronhorse.org or fax to 740-694-3604.
  - a. On or before January 31st of each year, the owner or lessee of every Registered Percheron stallion must make a written report showing the names and registration numbers of all Registered Percheron mares bred or exposed to said stallion since the previous January. The fee of \$10.00 per mare is required on Stallion Breeding Reports received by Percheron Horse Association with postmark after January 31st following the breeding year. **See note below\*.**
  - b. The report shall include all breeding dates or dates of exposure.
  - c. This report shall include all Percheron mares owned by the owner of the stallion as well as Percheron mares owned by other parties.
  - d. The report shall be made on a form provided free of charge by the Percheron Horse Association.
- 3. When an outside mare is brought to you to breed, demand to see the registration certificate of each mare exposed. This will assist you in the preparation of this report.
- 4. Be sure the last recorded owner of mare is the person who contracts the breeding to this stallion.
- 5. Give exact date(s) exposed -- if more than one service is given mare -- be sure and show the different dates.
- 6. If pasture exposed -- give date the mare was turned into the pasture and date she was taken out of pasture.
- 7. By circling Y in the Registration Approved column you are giving the PHAoA permission to register the resulting offspring from the breeding bypassing the receipt of Stallion Owner Approval at the time of registration.
- 8. Keep a copy of this report for your files and future use.

\*Note on rule 2 a----All registered Percheron mares bred or exposed means <u>ALL</u>; including those you think are not in foal, those the Veterinarian says are not in foal, those you do not intend to register the foal, etc.

ALL REGISTERED PERCHERON MARES BRED OR EXPOSED TO THE STALLION MUST BE LISTED ON THE STALLION REPORT.
