**Transfer Rules & Fees****Fees ~ The seller is responsible for paying transfer fee and fee is based on the seller's membership status.****PENALTIES FOR MAKING FALSE TRANSFERS** ~ The member executing this transfer, willfully failing to truthfully set forth the information herein requested by the by-laws, and/or the member accepting the same, shall be automatically suspended from membership in the Association and be subject to such penalty as provided by the By-Laws. Any buyer or seller, whether member or non-member, found guilty of giving or accepting a skipped transfer, a transfer signed in blank, a transfer with the wrong date of sale, a transfer of an animal that does not agree with its pedigree in color and description, or of making any other willful misrepresentation in connection with this transfer, with the intent to defraud, shall be subject to a heavy fine or to the extreme penalty of being forever barred from doing further business with this Association.**WHAT DATE GOVERNS AS DATE OF SALE** ~ Date of sale must be given as date when contract or agreement to sell was made and not some future date when animal is finally paid for. Date of delivery can be used as date of sale only when contract of sale covers privilege of showing and calls for delivery at some specific date. When the paperwork is received from the buyer, the penalty is automatically billed to the seller, (see By-laws, Article VIII, Section 1 (a)).**WARNING ABOUT MAILING FALSE PEDIGREES OR TRANSFERS**

The sending of a fraudulent application for registration, a fraudulent transfer or a fraudulent certificate of pedigree through the U.S. mail with the intent to defraud is a federal offense, subject to prosecution by the U.S. Government and punishable by a fine of not more than one thousand (\$1,000.00) or imprisonment of not more than five years or both.
